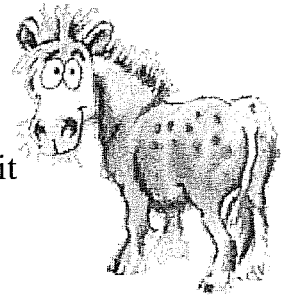
Just Horsin' Around 4-H Club
