A few points of interest:

- Our Management & General Expenses are higher this year than last. This is because during 2007 SAFE applied for its 501(c)(3) exemption, which cost a total of \$750 in application fees to the IRS, plus an additional \$40 to the State of Washington to revise our Articles of Incorporation. (The remaining \$10 in Business Licensing expenses was the fee for the annual renewal of our business license with the state of Washington)
- SAFE spent \$270 on the purchase of horses in 2007; as compared to \$915 in 2006. The majority of the horses taken in by SAFE in 2007 were surrendered or awarded to SAFE.
